CareNotesOnline™: Because most individuals receiving home healthcare services have multiple healthcare problems, CareNotesOnline™ is integrated with Life-SaverApp™, a personal health record that is immediately available in the event of a medical emergency.



Setup Fee: to initiate service through Care Notes Online™, there is \$200 setup fee. This setup fee includes registering your managers with Care Notes Online™, plus 4 hours of training for your managers and caregivers (eight 30 min. sessions or four 60 min. sessions.) Additional training is available for \$50 per hour.

Q: How does the QR code work?

A: When your client ID card is printed from Care Notes Online™, it includes a 2-D barcode created through QR codetechnology. When this code is scanned by a smart phone carried by a client's family member, the caregiving report is immediately available on the smart phone. To take advantage of this technology, client families only need to have downloaded a free QR code reader from iTunes. The caregiving report will automatically show the previous week's worth of caregiving notes.

In addition, caregivers can input daily notes using either a computer or a smart phone. Using smart phone technology, caregivers and client families have access to "real-time" data.

Q: I am hesitant to put my medical and personal data online. I have heard horror stories about hackers grabbing data. How does Care Notes Online™ protect the data?

A: This is a very good question. We realize the sensitivity of your client's data and have made every effort to protect it. First of all, the data is encrypted with 256 bit encryption, twice the HIPAA standard for privacy. Second, your data is stored on a secure website. When you are trained, you will be directed to our secure site to enter your data.

Q: Why have you included a photograph and physical description on the demographic page of Care Notes Online™?

A: Care Notes Online™ is part of an overall disaster plan/emergency preparedness program for individuals and families. In the event that a family member should disappear or go missing, Care Notes Online™ can make a missing persons report immediately available to law enforcement agencies much like the emergency medical report is available to emergency responders for medical emergencies.



Care Notes Online™ bridges the communication gap between home healthcare agencies or nursing homes providing daily care and family members in other cities or states that want to keep abreast with changes in their loved one's health.

In addition, the home healthcare agency or caregivers can include personalized health care notes or caregiving notes to help the family keep in touch with the needs and desires of the client. For example, the caregiver can indicate that the client needs to have an appointment with the dentist because the dentures are fitting loosely or that the client is complaining of frequent headaches.
